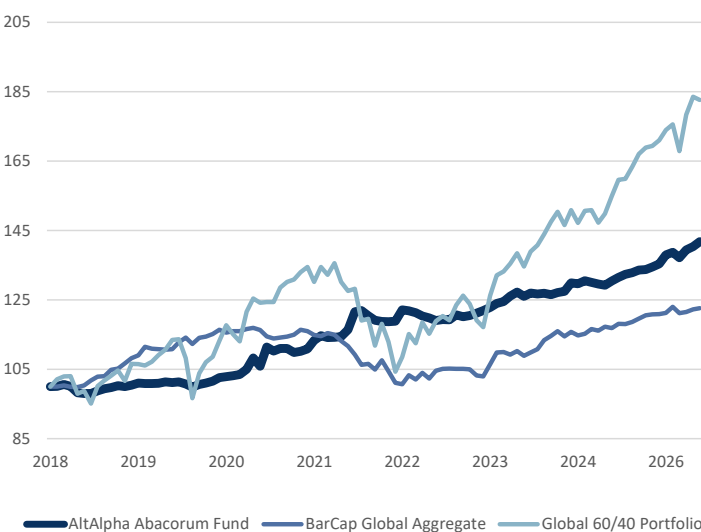
Fund Objective

The Abacorum Fund aims to deliver stable returns and capital preservation over various market cycles. This goal is achieved by deploying the Fund's capital in a diversified and well-balanced portfolio of hedge funds. The target return is 7 to 9% p.a. over a three to five years investment horizon, while maintaining a low to medium volatility profile with low correlation to traditional asset classes.

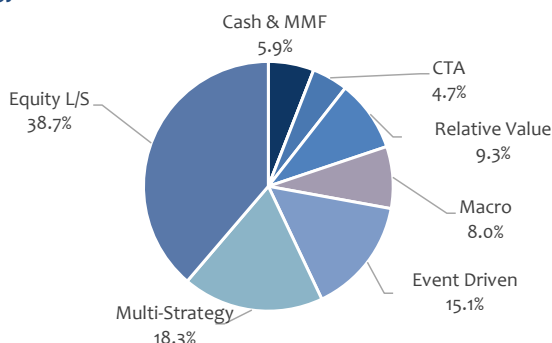

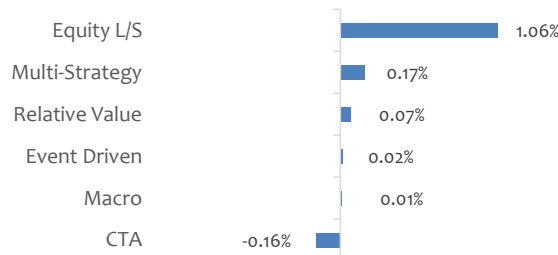

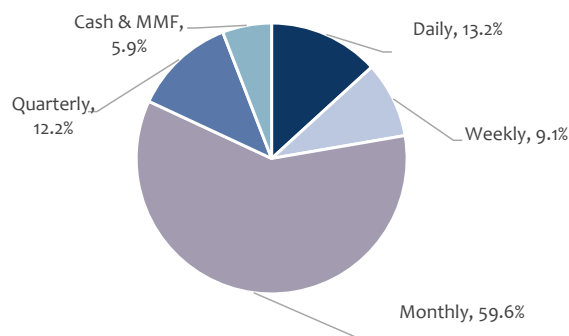


Strategy Contribution (Gross)

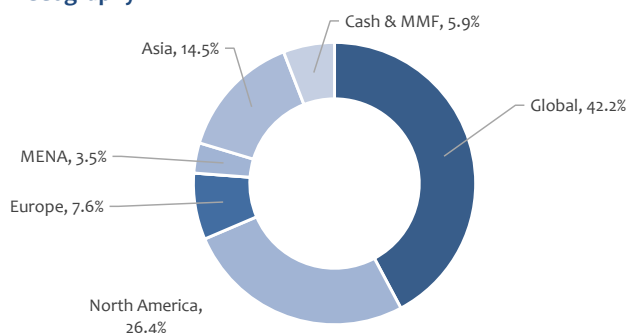

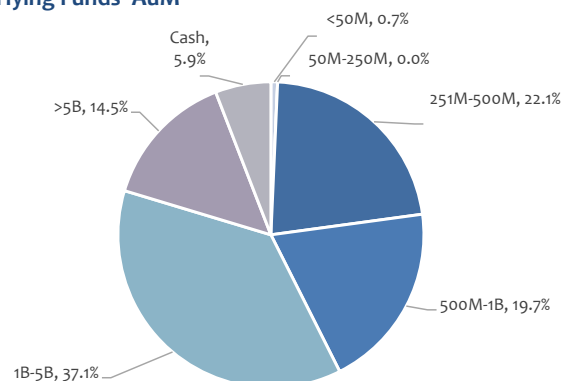
Underlying Funds' Liquidity



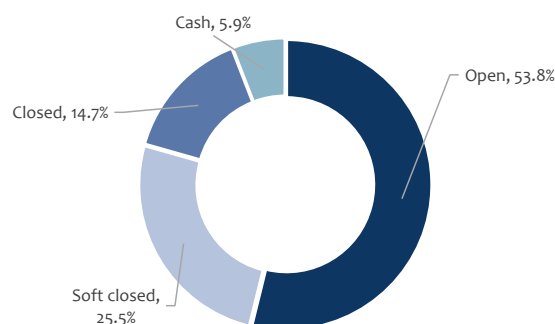
